7. Reporting Outcomes

Within 30 days of the end of each fiscal year (FY),¹¹ Pinellas County, Florida will create a CPP Report for the completed FY. The report will summarize efforts taken under this CPP in a narrative statement describing:

- 1. The specific steps taken to produce meaningful engagement with Affected Communities the completed FY,
- 2. The results of those efforts for the completed FY, and
- 3. How the Affected Communities' comments and views are or will be incorporated into the decision-making process.

The CPP Reports will be included with **Pinellas County, Florida**'s Title VI Plan. Because the Title VI Plan is updated every 3 years, the CPP Reports for the prior 3 years will be attached to the Title VI Plan. If no current Title VI Plan exists, the CPP Reports will be added to its Title VI Assessment for each grant.
